- 1) SYSTEM DESIGNED FOR 1 $\frac{1}{8}$ " OR 1 $\frac{1}{2}$ " INSULATING GLASS ONLY.
- 2) SKYLIGHTS ARE DESIGNED TO SUPPORT A MINIMUM 40 psf POSITIVE LOAD PLUS ALL DEAD LOADS WITH MAXIMUM DEFLECTION OF L/175.
- 3) SUPPORTING CURB CONSTRUCTION MUST BE CAPABLE OF SUPPORTING ALL HORIZONTAL AND VERTICAL LOADS IMPOSED BY THE SKYLIGHT ONTO THE CURB.
- 4) INSTALLATION OF SKYLIGHTS IS BY OTHERS.
- 5) OFF-LOADING OF SKYLIGHTS IS THE RESPONSIBILITY OF THE CUSTOMER.


